



## **2024 FOUR STATES FAIR & RODEO MUTTON BUSTIN' RULES**

1. PARTICIPANTS MUST WEIGH 55 POUNDS OR LESS, AND MUST BE SIGNED UP IN ADVANCE. ENTRY FEE IS \$20.
2. PARTICIPANTS ARE AGREEING TO BE IN THE ARENA BY 7:00PM, AND CHECK IN AT THE FAIR OFFICE (DOUBLE GLASS DOORS IN THE CENTER – ENTRANCE END OF THE ARENA) BY 7:30PM ON THE NIGHT OF THEIR PERFORMANCE. PARTICIPANT AND ONE PARENT WILL RECEIVE TICKETS WHEN ENTRY FEE IS PAID.
3. PARENTS/FAMILY MEMBERS WANTING TO WATCH THE EVENT MUST PURCHASE TICKETS TO THE RODEO PERFORMANCE. WE WILL TAKE THE FIRST TEN ENTRIES PER NIGHT. YOU MAY CHOOSE THE NIGHT YOU WANT TO PARTICIPATE.
4. THERE WILL BE NO REFUNDS FOR PARTICIPANTS NOT ABLE TO ATTEND.

I certify that the above information is correct and I understand that any misrepresentation will result in disqualification.
